## **CALL TO ORDER**

The meeting was called to order at 8:12 p.m. by Board of Education President, Nina Lanci. Mrs. Lanci led those present in the Pledge of Allegiance. Mrs. Cramsie then read the District's Mission Statement.

# APPROVAL OF MINUTES

Mrs. Cramsie moved that the Board of Education approve the Minutes from the regular meeting of October 10, 2013 and the Minutes from the special meeting of November 7, 2013. Mrs. DeLauter seconded, and the motion was carried 4-0.

# SPECIAL PRESENTATIONS

2013-14 District and Schools Accountability Status Report. Mrs. Pollitt announced that Martin Avenue, Newbridge Road and Saw Mill Road schools were named as Reward Schools by the State Education Department. The status report was based on data collected from the 2010-11 and 2011-12 school year. The five criteria are: Adequate Yearly Progress, Performance Index, Gap Closing, Student Growth Percentiles and Bottom Quartile Student Growth. She added that Dinkelmeyer and Park Avenue schools' performance was very near to that of the Reward Schools. All of the schools met the Adequate Yearly Progress standard, Performance Index and Gap Closing criteria.

# TREASURER'S REPORT

Mrs. DeLauter moved that the Board of Education approve the Treasurer's report for the month ended September 30, 2013. Mr. Mayo seconded and the motion and was carried 4-0.

# HIGH SCHOOL REPORT

Mrs. DeLauter reported that at the regular meeting of October 16, student representatives reported on student life in each of the high schools, Awards of Honor were presented to students who were selected as members of NYSSMA All State; Dr. Bollettieri presented the 2013-14 Enrollment Report, which reflected a decrease from last year. Deputy Superintendent, Ms. Regal, gave a presentation on the Nassau County tax debacle. At the November 6 work session, the external auditor presented the annual audit summary report for the school year ended June 30, 2013, which was very favorable. A presentation was given by the ELA and Math chairpersons and spoke about the Common Core Standards. At the regular of November 13 meeting three teachers from Calhoun High School and one teacher from Merrick Avenue Middle School were honored. The Annual Budget Vote date was set for May 20, 2014. Mrs. DeLauter noted that the High School District has a new web page. A resolution was passed that upon successful passage of the Bond Referendum, School Construction Consultants will provide the Construction Management Services to the district. DeLauter reminded the community that the Bond referendum vote will be held on December 2 at Newbridge Road School.

## STAFF DEVELOPMENT REPORT

Mrs. Cramsie moved that the Board of Education approve the Staff Development Report dated November 14, 2013. Mrs. DeLauter seconded and the motion was carried 4-0.

# BUSINESS DEPARTMENT UPDATE

Mr. Schissler thanked the Board for their volunteerism and dedication to the students and community. Mr. Schissler reminded the public of the December 31 deadline to apply for the Basic Star abatement. He reported that the district has received notification from the architect that plans for the handicap lift at Newbridge Road School has been approved by the State Education Department. He noted that the 2014-15 budget process has started and he is in the process of meeting with the principals and gathering information. He will be updating the Board each month as we move forward in the budget process. The budget workshops are planned to be held in March.

# BUILDINGS AND GROUNDS

In Mr. Russo's absence, Mr. Schissler reported that we are working on the fencing area off Newbridge Road. Mr. Schissler addressed concerns of Martin Avenue being crowded on Election Day and explained that repair work was taking place in the ceiling of the gym, while the students were not in school, and we will take that into consideration when scheduling future work on voting days. He added that Intralogic is continuing to make progress on the school district security project.

# CURRICULUM AND INSTRUCTION

Mrs. Pollitt reported that we are working collaboratively with the high school district. Mrs. Jafri went over to observe the 7th grade Spanish lessons and going forward we will with meet with the other departments as well. Mrs. Pollitt stated that she has met with all Math Leaders in an effort to attain our goal of aligning instruction with the Common Core Math Standards. Mrs. Pollitt thanked the Board for the many staff development opportunities that are helping teachers best support district initiatives and the Common Core. ELA consultant, Erica Percorale, is working with the grades 3-6 teachers relative to delivering enhanced balanced literacy instruction to meet the Common Core Learning Standards. Both she and Mrs. Hirschfield have visited 2 of our 4 UPK providers and reported that they are very receptive to information on the Common Core and things are going well.

## **TECHNOLOGY UPATE**

Mr. Fischetti reported that the technology staff continues to support the teachers in implementing the Common Core curriculum. He has met with librarians in the high school district to learn what our library media specialists should focus on to prepare our students for high school. The technology teachers have met with Ms. Speidel and our librarians to assist them in the research process. He reported that North Bellmore has joined a consortium through NASTECH that will work on creating Common Core Math Videos.

# SPECIAL EDUCATION CPSE/CSE

Mrs. DeLauter moved that the Board of Education approve the CPSE and CSE reports dated November 7, 2013. Mrs. Cramsie seconded and the motion was carried 4-0.

Mrs. DeLauter moved that the North Bellmore Board of Education approve the appointment of Allison Azus to the Committee on Special Education and the Section 504 Committee for the 2013/14 school year. Mrs. Cramsie seconded and the motion was carried 4-0.

In Ms. Eskew's absence, Mrs. Testa reported that Ms. Eskew is doing in depth research on allergies and developing an anaphylaxis emergency plan and district policy.

#### **VISITORS**

Mr. Amara (Columbus Ave.) asked when the next Parent University workshop will take place. Mrs. Pollitt stated that the next workshop will be held in December and will provide information on the web-based district subscriptions: World Book Online, FASTT Math, Study Island and Typing Training.

Mr. Amara asked if signs to slow down or speed bumps could be installed at Saw Mill Road school next to the parking lot. Mrs. Testa stated that she will look into it.

Mrs. Grote (Aron Pl.) asked for an update on the \$80,000 grant from Mr. Denenberg. Mr. Schissler stated that the district received approval from Nassau County for \$40,000 for the Little League and \$40,000 for the Saw Mill playground. Mr. Schissler added that he has spoken to the playground equipment vendor and he will be in contact with the Saw Mill PTA. The project will be scheduled for the spring.

Mrs. Adipietro (Pacific St.) spoke of security concerns at Saw Mill and asked about the possibility of changing the format of the main office so that the entrance of the office is at the entrance of the building. Mrs. Lanci said that the Board would look into the suggestion.

Mrs. Gambino (Acorn Pl.) thanked the Board of Education for all work they do for the children in North Bellmore. She asked for advice on how to present a petition for better security in the schools to the Board. Mrs. Lanci advised Mrs. Gambino to drop off the petition to the Business Office or the Superintendent's Office.

Mrs. Arale (Stratford Ct.) stated that she is gathering information from other Elementary districts on Long Island on how they handle security in the buildings and asked if the Board already has access to this information. Mrs. Testa stated she regularly meets with other superintendents and there are many different ways the districts are dealing with security issues. Mrs. Testa explained that North Bellmore has implemented extensive security measures and will soon be connected directly to the Nassau County Police Department in terms of reporting emergencies via direct communication devices.
