MODIFICATION OF HOURLY WAGES FOR PER DIEM EMPLOYEES

4. **BE IT RESOLVED** that the Board of Education of the North Bellmore Union Free School District hereby modifies the hourly wages of certain substitute per diem employees as follows effective January 31, 2022.

- Daily Substitute Teacher- Rate of pay is \$125.00/day
- Weekly Substitute Teacher- Rate of pay is \$135.00/day
- Math AIS Sub Teacher- Rate of pay is \$150.00/day
- Part-time Reading Teacher- Rate of pay is \$40.00/hour

**BE IT FURTHER RESOLVED** that the Board of Education of the North Bellmore Union Free School District authorizes and approves the modification of the hourly wage of all employees currently serving in the positions listed above effective January 31, 2022.
